7TH ST GAS LEAK EXPLOSION

In New York Times, Jordy Trachtenberg stated that there was no gas in the apartment for 6 months and on that day con Ed was doing work outside.

It has been said that the explosion that happened near east harlem a year ago was caused by the gas of the same company Con Ed. There was a crack in the pipe that leaked the gas.

On a different article on New York Times, Law enforcement officials are investigating whether the explosion that destroyed three buildings and killed two men resulted in an attempt to hide the unauthorized siphoning of natural gas for tenants.

The apparatus that was siphoning gas was dismantled before authorities left, an attempt to re-attach the apparatus made a bomb go off.

It also says that Con edison found out that someone was tapping into the gas pipe from August. They only stated that it was a "hazardous situation" and was intended as a stopgap. There definitely was a siphoning apparatus and Con Edison failed to find and get rid of it.

Con Edison workers left t the head of the pipe locked because the building was unprepared to receive gas through the bigger pipe. However after talking to the owner of Sushi Park, they figured out that there was a black pipe that was not connected to the one that was supplying the store. Therefore, the head of that pipe was not locked and con edison was checking the wrong pipe.

ALSO there is a theory from the investigators in that the landlord, maria hrynenko or others might have instructed residents on how to respong to the questions from con edison workers about gas service. The manager did not know where the gas pipe started because it started from and connected to the next door restaurant that ms. Hrynenko owned.

Mr. Kim wondered where the upstairs tenants obtained gas that fueled their water heaters and stoves if the gas had been shut off for 6 months.

the manager noticed the distinct rotten-egg odor of gas and called the land lord. She did not do anything about it, therefore the manager was worried and opened the door and was flung him out to the street. the manager was injured.

A survey conducted of the gas mains on the block found no leaks, however sources have said when on of the workers went down into the basement and opened the door, "everything exploded.

Background of the Buildings

Three of the four buildings that were affected in the 2015 gas explosion on East 7th St in New York City was 121, 119, 123, and 125. Buildings #121, #119, and #123 were destroyed, whereas #125 although damaged, remained intact. These buildings had landmark status being part of the East Village/Lower East Side Historic District with #121 Queen Anne Style building which was constructed around the early 1800s, the #123 building built in 1834, and the #125 Renaissance Revival style building that was built by George F. Pelham. [By the 1850s large numbers of immigrants began to settle in the area as wealthier residents moved farther uptown. Many of the existing row houses were converted for multiple- family dwellings and boarding houses, and eventually new purpose-built tenements began to replace the older building stock. These buildings, known as "pre-law" tenements because they predated the Tenement House Act of 1879, were designed in a simplified version of the Italianate style that had become the dominant mode of architecture in New York City.] (NYC.gov)
